OPEN CALL FOR PARTNERS

Art. 1 – Subject and objectives

This Call is open to private and public organisations wishing to establish a partnership, with the leadership of Istituto degli Innocenti, in any occasion or public/open selection where a collaborative project has to be forwarded to any private or public Body, at sub-national, national, international level.

The aim is to make a list of qualified potential partners in relevant fields of action. Therefore, applying to the Call - and accepting the registration - are only intended to share opportunities, without any obligation to finalize agreements nor support any legally binding position.

Art. 2 - Scope

The potential partners shall be involved in projects/actions whose scope is limited by the mission stated in the Istituto degli Innocenti Statute, such as those concerning:

1. policy monitoring and reasearch, documentation, training, media education, especially related to child policies and services, familes, motherwood, condition of the women.
2. Social assistance, education, social services for children, adolescents, families, parents;
3. Learning and vocational training for those working with children, famimies in education, training, social, health, psychological, legasl services;
4. promotion of child rights, inclusion and combat to any kind of discrimination. .

Alternatively, the projects may concern adjoining or different fields, provided anyway that complementary or functional actions fit to the above mentioned statutory mission.

Art. 3 - Requirements

Any private or public, italian or non-italian, profit or non-profit organisation with adequate qualification in ther own field can apply.
